Invoice for Royalties on PVMI Varieties for the 2008 Crop

Please fill in the information below as it applies to you and the PVMI varieties you grew in 2008, return it with your check for the royalties within 30 days of sale. The royalty assessment is a flat rate fee based on where you are located, where the seed is grown (\$.25/CWT for seed grown in the Tri-States; \$.50/CWT for seed grown in the US and outside the Tri-States; \$1.00US/CWT for all seed grown outside the US).

Examples to calculate royalties due:
