**Invoice for Royalties on PVMI Varieties for the 2023 Crop**

Please fill in the information below as it applies to you and the PVMI varieties you grew in 2023 and return it with your check for the royalties within 30 days of sale. The royalty assessment is a flat rate fee based on the type of seed and where the seed is grown:

- \$0.25/CWT** for non-specialty seed grown in the **Tri-States** and \$1.00/CWT for specialty seed\*
- \$0.50/CWT** for non-specialty seed grown in the **US and outside the Tri-States** and \$1.00/CWT for specialty seed\*
- US\$1.00/CWT** for all non-specialty seed grown **outside the US** and US\$2.00/CWT for specialty seed\*

\*Specialty seed is defined presently as including *AmaRosa, Huckleberry Gold, Purple Pelisse* and other varieties shown on the next page in *italics*.

Examples to calculate royalties due:

	<u>CWT</u>		<u>Rate</u>	=	<u>Royalty Due</u>
2400 CWT <b>PVMI</b> non-specialty seed grown in North Dakota	2400	x	\$ .50	=	\$ 1,200
600 CWT <b>PVMI</b> specialty seed grown in Oregon	600	x	\$1.00	=	\$ 600
40,000 CWT <b>PVMI</b> non-specialty seed grown in Idaho	40,000	x	\$ .25	=	\$10,000
1150 CWT <b>PVMI</b> seed grown in New Brunswick, Canada	1150	x	\$1.00	=	\$ 1,150

**For potatoes sold for non-seed purposes (e.g. dehy, processing, fresh) the royalty rate is 1/10 of that shown above. If potatoes were not sold, that is they were discarded, culled, etc. - please indicate below. No royalties are due.**
