Invoice for Royalties on PVMI Varieties for the 2023 Crop

Please fill in the information below as it applies to you and the PVMI varieties you grew in 2022 and return it with your check for the royalties within 30 days of sale. The royalty assessment is a flat rate fee based on the type of seed and where the seed is grown: \$0.25/CWT

for non-specialty seed grown in the Tri-States and \$1.00/CWT for specialty seed\*

\$0.50/CWT for non-specialty seed grown in the US and outside the Tri-States and \$1.00/CWT for specialty seed\*

## US\$1.00/CWT for all non-specialty seed grown outside the US (Canada) and US\$2.00/CWT for specialty seed\*

\*Specialty seed is defined presently as including AmaRosa, Huckleberry Gold, Purple Pelisse and other varieties shown on the next page in italics.
